ORDER

1. WHEREAS, directions for phased reopening of prohibited activities were issued vide Orders of 1.6.2020 and 6.6.2020 as per the guidelines received from the Ministry of Home Affairs, Government of India and Department of Home, Government of Punjab (DoH, GoP);
2. WHEREAS, a rise in COVID cases has been observed in the state and accordingly additional guidelines have been received from DoH, GoP.
3. THEREFORE, I, Girish Dayalan, IAS, District Magistrate, in exercise of powers conferred under Section 144 of Cr. PC hereby order the following:
 - a) All shops/ shopping malls/ stand-alone shops other than those mentioned in paragraph 3(b) shall remain closed on Sunday. On Saturdays and gazetted holidays they shall be permitted to open till 5.00 PM;
 - b) Shops dealing with essential commodities/ services such as food items, fruits, vegetables, milk, dairy products, medicines, medical equipment, LPG, POL, animal feed etc. will continue to be allowed to open till 7.00 PM on all days.
 - c) Restaurants (for take home/ home delivery only) and liquor shops will continue to be open till 8.00 P.M on all days.
 - d) For all days other than Saturday, Sunday and public holidays, orders dated 1.6.2020 and 6.6.2020 shall continue to be applicable.
 - e) Inter-district movement shall be allowed against e-passes which will be issued only for essential work. In case of medical emergency, no pass shall be required.
 - f) Marriage functions up to 50 persons will be permitted against e-pass which will be issued for up to 50 specific persons on all days.
 - g) All other social gatherings shall be strictly prohibited on Saturdays, Sundays and gazetted holidays and non-essential movement shall be strictly avoided on these days.
 - h) To balance the need to secure livelihoods, all industry/ offices/ banks shall be allowed to operate and movement of workers/ personnel to and from work shall be allowed on production of ID Cards issued by the employers.
4. **Any violations shall invite criminal proceedings under the relevant provisions of the Disaster Management Act, 2005 and the Indian Penal Code, 1860.**
